# Topic 1: ARTICLE 244 A

## Importance for Prelims: Polity

Congress leader Rahul Gandhi pledge to implement Article 244 (A) of the Constitution to safeguard the interests of the folks in Assam's tribal-majority districts.

- Article 244(A) allows for creation of an 'autonomous state' within Assam in certain tribal areas.
- Inserted into the Constitution in 1969, it also has a provision for a Legislature and a Council of Ministers.
- Under Article 244(A)(1), the Parliament may, by law, form within the State of Assaman autonomous State comprising all or any of the tribal areas.

### How is it different from the Sixth Schedule of the Constitution?

- The Sixth Schedule of the Constitution Articles 244(2) and 275(1) is a specialprovision that permits for bigger political autonomy and decentralized governance incertain inherited areas of the Northeast through autonomous councils that areadministered by electoral representatives.
- In Assam, the Hill districts of Dima Hasao, KarbiAnglong and West Karbi and also the Bodo Territorial Region are below this provision.
- Article 244(A) accounts for more autonomous powers to inherited areas.
- In Autonomous Councils below the Sixth Schedule, they do not have jurisdiction of law and order.







# **Topic 2: AIM PRIME**

Importance for Prelims: Governance



Recently, the NITI Aayog has launched the 'AIM-PRIME' (Program for Researchers on Innovations, Market-Readiness & Entrepreneurship).

### **About AIM-PRIME**

- It is an initiative of the NITI Aayog's Atal Innovation Mission (AIM) in partnership with Bill & Melinda Gates Foundation (BMGF).
- It is a nationwide program which is able to be implemented by Venture Center (a non profit technology business incubator).
- The 1st cohort of the program is technology developers (early-stage deep tech start-ups, and scientists/ engineers/ clinicians).
- The program is additionally hospitable CEOs and senior incubation managers of AIM funded Atal Incubation Centers that square measure supporting deep tech entrepreneurs.
- It is catalyzed by the workplace of the Principal Scientific adviser and the Pune knowledge Cluster.








# **Topic 3: DNA PROFILING**


- As a result, DNA technology is being increasingly relied upon in investigations of crime, identification of unidentified bodies, or in determinant parentage.

# **Topic 4: PLI FOR FOOD PROCESSING SECTOR**

Importance for Prelims: Government Schemes



The Union cabinet has approved the Central Sector scheme – "Production connected incentive program for Food processing business (PLISFPI)" with an outlay of Rs.10900 crore.

The objectives of the scheme are to support food producing entities with stipulated minimum Sales and willing to create minimum stipulated investment for enlargement of processing capacity and branding abroad to incentivise emergence of sturdy Indian brands.

- The scheme are extended on All Indian basis.
- The scheme shall be enforced through a Project Management Agency (PMA).
- The scheme would be monitored at Centre by the authorized group of Secretaries chaired by the cabinet Secretary.
- The period of the scheme are going to be six years i.e., 2021-22 to 2026-27. The incentive below the scheme would be paid six years ending 2026-27.
- The scheme is "fund-limited", i.e., price shall be restricted to the approved amount.
