# Topic 3. NARCOTIC DRUGS AND PSYCHOTROPIC SUBSTANCES

#### <u>ACT 1985</u>

#### Importance for Prelims: Legislations

The Delhi High Court has observed that the menace of drug abuse was on the rise in the country and its consequences "can be experienced across the board from causing economic issues to societal disintegration".

- The Narcotic Drugs and Psychotropic Substances Act is an Act of the Parliament of India that prohibits a person to produce/manufacture/cultivate, possess, sell, purchase, transport, store, and/or consume any narcotic drug or psychotropic substance.
- As per the NDPS Act, narcotic drugs include coca leaf, cannabis (hemp), opium and poppy straw.
- Psychotropic substance means any natural or synthetic material or any salt or preparation covered under the 1971 convention on Psychotropic substances.
- The following conventions various forms of control to limit the use of narcotic drugs and psychotropic substances
- The international organisation Single Convention on Narcotics medicine 1961 The Convention on mind-altering Substances, 1971 The Convention on Illicit Traffic in Narcotic medicine and mindaltering Substances, 1988 Asian nation may be a human to any or all these 3.
- NDPS Act has created tight provisions for the management and regulation of operations with reference to narcotic medicine and mindaltering substances.
- As per the NDPS Act, the minimum sentence for coping with medicine is ten years rigorous imprisonment including a fine of Rs.
  1 lakh. No bail is granted for those persons reserved underneath this act.

- In addition, no relief will be obtained by the drug convicts through suspension, remission and commutation of sentences passed.
- NDPS Act prescribes even though the offence cannot be called as a heinous crime. Narcotics Control Bureau
- It was constituted by the Government of India in1986 under the Narcotic Drugs and Psychotropic Substances Act, 1985.
- It is the apex coordinating agency under the Ministry of Home Affairs.
- The National Policy on Narcotic medicine and mindaltering Substances relies on Article forty seven of the Indian Constitution that directs the State to endeavour to achieve prohibition of the consumption, apart from healthful functions, of intoxicating medicine injurious to health.
- Drug abuse management is that the responsibility of the central government.



#### Importance for Prelims: Economy


The off shore NDF market for the rupee remains a challenge, despite RBI's attempts to curb its influence.

- NDFs square measure exchange by-product instruments on nonconvertible or restricted currencies listed over the counter (OTC) primarily at offshore centres outside the direct jurisdiction of the individual national authorities.
- NDF may be a exchange derivatives contract whereby 2 parties conform to exchange money at a given spot rate on a future date.
- The contract is settled in a widely traded currency, such as the US dollar, rather than the original currency
- The Task Force on Offshore Rupee Markets, found out by the run batted in (chaired by Usha Thorat, former Deputy Governor, RBI) had projected that Indian banks shouldn't be allowable to deal within the offshore rupee by-product market — or the NDF market — for the current because the draw back of allowing them to deal during this market outweighs the benefits.
- However, The banking company of Asian country|Bharat|Asian country|Asian nation} (RBI) has determined to allow banks in India, that operate International money Services Centre Banking Units (IBUs), to participate within the non-deliverable forward (NDF) market with result from June one, 2020.
- ['Onshore' currencies merely mean shopping for the currencies regionally, whereas 'offshore' currencies mean shopping for the currencies outside the national boundaries].


- Competition Commission of India is a statutory body responsible for enforcing the objectives of the Competition Act, 2002.
- CCI was established by the Central Government with effect from 14 October 2003, but it became fully functional on 20 May, 2009.
- **Composition A** Chairperson and 6 Members appointed by the Central Government.
- Formation of CCI: The CCI was established below the provisions of the Competition act 2002: The Competition Act, 2007, was enacted when amending Competition Act, 2002, that semiconductor diode to the institution of the CCI and also the Competition legal proceeding assembly.
- The government replaced the Competition legal proceeding assembly (COMPAT) with the National Company Law legal proceeding assembly (NCLAT) in 2017.
- Function of CCI To eliminate practices having adverse effects on competition, promote and sustain competition, protect the interests of consumers and ensure freedom of trade in the markets of India.

**Topic 10. SREE NARAYANA GURU** 

Importance for Prelims: History



Kerala Chief Minister Pinarayi Vijayan on weekday aforesaid the powerful current of humanism that animated the teachings of nineteenth century social reformer Sree Narayana Guru may be a cure-all for the globe riven by communal and racial conflicts.

- Narayana Guru (1856 1928) was a social reformer.
- He has been attributable with remodeling the social material of kerala and dynamical the beliefs of keralites in ways that unthinkable at that time in time.

- His family belonged to the Ezhava caste and was thought of 'avarna' in keeping with the social mores of the time.
- From AN early age, he was drawn towards asceticism. He lived as a hermit in an exceedingly forest for eight years.
- He learned Vedas, Upanishads, literature, logical rhetoric of Sanskrit, Hatha Yoga and other philosophies.
- He gave the famous slogan "One Caste, One Religion, One God for All" (Oru Jathi, Oru Matham, Oru Daivam, Manushyanu).
- In 1888, he engineered a temple dedicated to Lord Shiva at Aruvippuram that was against the caste-based restrictions of the time.
- In one temple he consecrated at Kalavancode, he unbroken mirrors rather than idols.
- This symbolised his message that the divine was among every individual. Narayana Guru organized AN All-Region Conference in 1923 at Alwaye Advaita Ashram, that was reported to be the primary such event in India.
- This was an endeavor to counter the spiritual conversions Ezhava community was prone to.
- Sree Narayana Guru became one amongst the best proponents and reevaluators of Advaita Vedanta, the principle of non-duality proposes by Adi Shankara.
- He wrote numerous books in numerous languages. Few of them are: Advaitha Deepika, Asrama, The varappathinkangal, etc. Contribution to National Movement: a noteworthy social reformer, he was within the forefront of the movement for universal temple entry and against the social ills just like the social discrimination of untouchables.
- Narayana Gurudev provided the impetus for Vaikom agitation which was aimed at temple entry in Travancore for the lower castes.
- It histrion nationwide attention and appreciation from spiritual leader.

- The Indian government has introduced a special category of electronic visa the 'e-Emergency X-Misc Visa' to facilitate and fast-track urgent applications for entry to India.
- The new visa provision has been introduced particularly for Afghans because the state of affairs worsens within the warworn nation condemned by the religious movement.
- Then e-Emergency X-Misc Visa is granted to foreigners WHO aren't lined within the accessible classes of visa however ought to visit India desperately thanks to a family emergency.
- Such a single-entry visa is issued by Indian Missions/Posts for associate degree acceptable amount of your time.
- According to the older document,
   Afghans weren't lined below the class and had to
   physically gift themselves at the Embassy to induce the visa.
- However, given the current situation in Kabul, which has forced to shut down the embassy as well, all Afghans have been permitted to open e-visa with no religion-based priority.
- The facility is available to all Afghans irrespective of their religion.
- The (initial) validity of this visa would be six months.

- Prime Minister launched the second phase of Pradhan Mantri Ujjwala Yojana (PMUY) or Ujjwala 2.0 Scheme.
- PMUY-I: Launched in might 2016 to supply LPG (liquefied fossil oil gas) connections to poor households.
- **PMUY-II:** It is aimed to provide maximum benefit to the migrants who live in other states and find it difficult to submit address proof.
- Now they will only have to give "Self Declaration" to avail the benefit.
- The scheme provides a financial support of Rs 1600 for each LPG connection to the BPL households.
- Along with a deposit-free LPG association, Ujjwala 2.0 can give the primary refill and a kitchen appliance freed from value to the beneficiaries.
- Under Ujjwala 2.0, an additional 10 million LPG connections will be



Importance for Prelims: Environment

- Jim Corbett park is that the oldest park in Bharat and was established in 1936 as Hailey park to guard the vulnerable tiger.
- It is found in Nainital district and Pauri Garhwal district of Uttarakhand and was named when hunter and naturalist Corbett.
- The Park was the primary to come back underneath the Project Tiger initiative.
- The Park encompasses the Patli Dun depression shaped by the Ramganga stream.
- Ramganga, Sonanadi, Mandal, Palain and Kosi are the major rivers flowing through the Corbett National Park.

- It was established in 2005 following the recommendations of the Tiger Task Force.

#### **Topic 14. URBAN CO-OPERATIVE BANKS**

#### Importance for Prelims: Economy

A Reserve Bank appointed committee has suggested a fourtier structure for the urban cooperative banks (UCBs).

- Co-operative Banks, which are distinct from commercial banks, were born out of the concept of co-operative credit societies where members from a community group together to extend loans to each other, at favourable terms.
- Co-operative Banks square measure broadly speaking classified into Urban and Rural co-operative banks supported their region of operation.
- Like other banks, the cooperative banks are founded by collecting funds through shares, accept deposits and grant loans.
- The history of Indian cooperative banking started with the passing of Cooperative Societies Act in 1904.
- A Co-operative bank could be a money entity that belongs to its members, World Health Organization square measure at a similar time the homeowners and therefore the customers of their bank.
- Co-operative banks in India are registered under the States Cooperative Societies Act.
- The Co-operative banks also are regulated by the bank of India (RBI) and ruled by the Banking laws Act 1949 Banking Laws (Co-operative Societies) Act, 1955.
- **Democratic Member management** democratically elect a board of administrators. Members typically have equal pick rights, in line with the cooperative principle of "one person, one vote".
- Urban Co-operative Banks (aka Primary Cooperative Banks) square measure regulated and supervised by State Registrars of Co-operative Societies (RCS) just {in case} of single-State co-operative banks and

Central Registrar of Co-operative Societies (CRCS) in case of multi-State co-operative banks and by the tally.

- The banking connected functions like issue of license to begin new banks/branches, matters regarding interest rates, loan policies, investments and prudent exposure norms square measure regulated and supervised by the bank beneath the provisions of the Banking Regulation Act, 1949.
- Reserve Bank of India is both the controlling and inspecting authority for the Primary Cooperative Banks.
- NABARD provides refinance support and takes care of inspection of StCBs and DCCBs.
- Difference between UCBs and Commercial Banks Regulation: Unlike commercial banks, UCBs are only partly regulated by the RBI.
- Their banking operations square measure regulated by the tally, that lays down their capital adequacy, risk management and disposition norms.
- However, their management and backbone within the case of distress is regulated by the Registrar of Co-operative Societies either beneath the State or Central government.
- Borrower will be a Shareholder: generally for an advertisement bank, there's a transparent distinction between its shareholders and its borrowers whereas in an exceedingly UCB, borrowers will even double up as shareholders.
- All-inclusive directions (AID) The committee, headed by NS Vishwanathan, a former Deputy Governor of the tally, emphatic that allembracing directions (AID) ought to be treated on a par with moratorium beneath Section forty five of the Banking Regulation Act.
- If AID is obligatory, a bank mustn't continue under that on the far side the time allowable to stay a bank beneath moratorium 3 months long by



#### **Topic 15. POTASH**

Importance for Prelims: Agriculture



EID Parry (India) Ltd., one in all the most important sugar makers within the South, has undertaken a pilot study to determine the extraction of hydroxide from ash created in distilleries.

- Potash includes various mined and manufactured salts that contain potassium in water-soluble form.
- The name derives from pot ash, which refers to plant ashes or wood ash soaked in water in a pot, which was the primary means of manufacturing the product before the Industrial Era.
- Potash is produced worldwide in amounts exceeding 90 million tonnes (40 million tonnes K O equivalent) per year, mostly for use in fertilizer.
- Potassium was first derived in 1807 by electrolysis of caustic potash (potassium hydroxide).
- Most of the world's potash comes from Canada, with the largest deposits located in Saskatchewan and New Brunswick.
- Four countries (Canada, Belarus, Russia and China) accounted for 80% of

the world's potash production in 2019.

- Today, hydroxide comes from either underground or resolution mining.
   In India, few deposits of hydroxide mineral area unit according from Sidhi district of Madhya Pradesh, Sonbhadra district of Uttar Pradesh, Kaimur district of state and Sawai Madhopur and Karauli districts of Rajasthan.
- It is in the form of Glauconitic (a potassium bearing green mica) sandstone.
- Potassium is a vital component of the human diet because it is important for growth and also the maintenance of tissues, muscles and organs, still because the electrical activity of the center.

- If Parliament isn't in session, a cupboard minister is in remission by a enforcement agency just in case of a criminal case registered against him.
- As per Section twenty two A of the foundations of Procedures and Conduct of Business of the Rajya Sabha, the Police, choose or functionary would, however, ought to intimate the Chairman of the Rajya Sabha concerning the rationale for the arrest, the place of detention or imprisonment in Associate in Nursing acceptable type.
- The Chairman is predicted to tell the Council if it's sitting concerning the arrest.
- If the council isn't sitting, he/she is predicted to publish it within the bulletin for the data of the members.
- Privileges of the Rajya Sabha members vis-a-vis arrests as per the most privileges of Parliament, in civil cases, they need freedom from arrest throughout the continuance of the House and forty days before its commencement and forty days when its conclusion, as per section one hundred thirty five of the Code of Civil Procedure.
- The privilege of freedom from arrest doesn't touch criminal offences or cases of detention below preventive detention.

#### Can someone be in remission from the precincts of the House?

• No arrest, whether of a member or of a stranger, can be made within the precincts of the House without the prior permission of the

- The Sikhs take into account the saroop of Guru religious writing a living guru and treat it with utmost respect.
- They believe that each one the ten Gurus were identical spirit in numerous bodies, and therefore the Guru religious writing is their eternal physical and religious type.
- It was the fifth Sikh master, Guru Arjan Dev, WHO compiled the primary Bir of the Guru religious writing in 1604, and put in it at the Golden Temple in Amritsar.
- Later, the tenth Sikh master, Guru Gobind Singh, added verses fenced in by the ninth master, his father Guru Tegh Bahadur, and compiled the Bir for the second and last time.
- It was in 1708 that Guru Gobind Singh declared the Guru religious writing the living Guru of the Sikhs. "Guru religious writing may be a compendium of hymns written by six Sikh gurus, 15 saints, as well as BhagatKabir, BhagatRavidas, Arab chief Farid and BhagatNamdev, eleven Bhatts (balladeers) and 4 Sikhs. The verses square measure composed in thirty one ragas."
- The installation and transportation of Guru religious writing is ruled by a strict code of conduct known as rehatmaryada. below ideal circumstances, 5 baptized Sikhs square measure needed to transfer the

- Gurdwaras have a separate resting place for the Saroop, known as 'SukhAsanSthan' or 'Sachkhand' wherever the Guru rests in the dead of night.
- This takes place at the top of the day once the holy book is ceremonially shut and untired.
- In the morning, the saroop is once more put in in an exceedingly ceremony known as 'prakash'.

#### wherever square measure copies of the Guru sacred text published?

- There was a convention among Punjabis, each Sikhs and Hindus, to repeat the Guru sacred text by hand and turn out multiple copies.
- The Udasi and Nirmla sects additionally vie a job in creating written copies of the Birs till land introduced the press.
- The British additionally revealed many tiny copies of the Guru sacred text for his or her Sikh troopers so they might carry these with them within the tract.
- Nowadays, the Shiromani Gurdwara Parbandhak Committee (SGPC) has the only rights to publish the Birs of the Guru sacred text, and this is often done at Amritsar.

- During the Sixth BRICS Summit in Fortaleza (2014) the leaders signed the Agreement establishing the New Development Bank (NDB),



### Topic 29. LUMPY SKIN DISEASE (LSD)

### Importance for Prelims: Science and Tech

- Lumpy disease of the skin (LSD) has been infecting India's bovines.

- The virus is one of three closely related species within the genus capripox virus, the other two species being Sheeppox virus and Goatpox virus.
- **Symptoms** It appears as nodules of two to five centimetre diameter all over the body, particularly around the head, neck, limbs, udder (mammary gland of female cattle) and genitals.
- Other clinical signs embrace general unease, ocular and nasal discharge, fever, and fast decrease in milk production.
- According to the Food and Agriculture Organization (FAO) the morbidity is a smaller amount than 100 percent.
- **Vectors** it spreads through mosquitoes, flies and ticks and conjointly through spittle and contaminated water and food.
- Control and prevention of lumpy skin disease relies on four tactics movement control (quarantine), vaccination, slaughter campaigns and management strategies.
- There is no treatment for the virus, so prevention by vaccination is the most effective means of control.
- Secondary infections within the skin {may be|could conjointly be|is also} treated with Non-Steroidal Anti-Inflammatories (NSAIDs) and also antibiotics once acceptable.

- **Radioactivity:** The spontaneous decay of an unstable atomic nucleus, giving rise to the emission of radiation. Uranium (U): A mildly radioactive element with two isotopes which are fissile (U-235 and U-233) and two which are fertile (U-238 and U-234).
- Uranium is that the basic fuel of energy.
- Vitrification: The incorporation of high-level wastes into salt glass, to form up regarding Bastille Day of it by mass.

- E-Waste Management Rules, 2016 The Ministry of setting, Forest and global climate change notified the E-Waste Management Rules, 2016 in replacing of the E-waste (Management & Handling) Rules, 2011.
- Over twenty one merchandise (Schedule-I) were enclosed below the orbit of the rule.



- Section eight (3)of the Act states that if associate MP or MLA is condemned for the other crime and is shipped to jail for two years or a lot of, he/ she is going to be disqualified for six years from the time of unharness.
- Even if an individual is on bail when the conviction and his charm is unfinished for disposal, he's disqualified from contesting associate election.
- Section 8(4) allowed condemned MPs, MLAs and MLCs to continue in their posts, provided they appealed against their conviction/sentence in higher courts inside three months of the date of judgment by the tribunal.
- The Supreme Court in liliaceous plant Thomas Case, 2013 smitten down section 8(4) of the RPA, 1951 and declared it ultra vires and command that the disqualification takes place from the date of conviction.
- Recently, the CJI Bench more aforementioned a lot of special Central Bureau of Investigation (CBI) courts required to be originated in places wherever quite a hundred cases were unfinished "to guarantee simple accessibility to the witnesses and decongestion of existing special/CBI courts".

- For his bravery and wildness, the govt. of Republic of India free a stamp on the name of Nalwa in 2013.
- Hari Singh Nalwa participated in varied battles against Afghans as a result of that Afghans lost their management over varied Afghan-held territories and most of those battles were fought beneath the command of Hari Singh Nalwa. Like in 1807, at the age of sixteen, he participated within the battle of Kasur (now in Pakistan) and defeated Afghani ruler Kutab-ud-din Khan.
- In the Battle of Attock (in 1813) Nalwa together with different commanders won against Azim Khan and his brother Dost prophet Khan, WHO fought on behalf of sovereign Mahmud of national capital and this was the primary major conclusion of the Sikhs over the Durrani Pathans.
- In 1818, Sikh army beneath Nalwa won the Battle of metropolis and Nalwa asked to be stationed there. Nalwa took management over Jamrud in 1837, a fort at the entrance to Asian country through mountain pass.
- Historians aforementioned that within the battle of Jamrud, wherever Hari Singh Nalwa had died, Dost Muhammad Khan together with his 5 sons participated against Sikh army that was restricted in range (around 600) with restricted provides.
- He was additionally known as 'Bagh Maar' (killer of tiger) once associate



- Since infrastructure-oriented projects tend to take time to generate substantial cash flow, InvITs come in handy for paying off loan interests and other expenses conveniently.


