Topic 1. Tussle between Central vs Union Government

Importance for Prelims: Polity

Recently, an argument erupted over the new DMK government concerning the govt. of Prime Minister Narendra Modi because the 'union government' rather than 'central government'.

- Central v/s Union Government Justice (retd) K Chandru had got wind that quite seventy years when Independence, there's no authorised Tamil translation of the Constitution of Asian country.
- The question within the 'union or centre' discussion is concerning the character of the Indian state.
- the govt. of Asian country Act, 1935, provinces had additional power and also the Viceroy had solely the minimum however the Indian constitution modified this equation, and also the central was created additional powerful.
- The actual power is unconditional with the Union of Asian country all told respects.
- The Tamil Nadu government expressed that the Constitution describes Asian country as a "Union of States" and so the best regard to the Centre would be the "Union Government".
- Constitutional Provisions for Central or Union Government Article 1(1) of the Constitution of {india|India|Republic of Asian country|Bharat|Asian country|Asian nation} says that India, that's Republic of India, shall be a Union of States.
- The chairman of the drafting committee of the Indian Constitution had used the planet 'Union' because: The Indian federation wasn't the results of AN agreement by the units; and also the element units had no freedom to break up from the federation.







- The Indian Constitution perpetually uses the word "Union" to explain the whole country yet because the government that administers it.
- Article fifty three reads that the chief power of the Union shall be unconditional within the President. The 'Central government' could be a term not employed in the first Constitution as glided by the Constituent Assembly.
- The Preamble clearly demonstrates the federal kind, spirit associated content of the Indian Constitution with an open acknowledgement of consolidative tendencies quasi-federal the and also the characteristics within the actual operating of the Constitution.
- The seventh schedule (Article-246) of the Constitution contains the Union List ninety seven things, State List with with six things and synchronic List with forty seven things.
- Reasons to be used of Central or Union Government country Parliament passed the regulation Act, appointing a governor to manage all of British Asian country.
- The administration that the governor ran was typically delineated because the "Central Government" so as to differentiate it from the "provincial governments".
- The Government of India Act 1919 introduced a rudimentary form of selfgovernment and federalism in India and the powers were split between "central" and "provincial" subjects.
- The Government of India Act 1935 proposed a merger between British India and the princely states that the term "Federation of India" was first used.
- The modern term "Union" was first officially used in 1946 by the Cabinet Mission Plan.







Topic 2. National Disaster Management Authority

Importance for Prelims: National Organisations



The Supreme Court directed the National Disaster Management Authority (NDMA) to border tips for payment of ex-gratia compensation to relations of persons United Nations agency succumbed to COVID-19.

- It conjointly directed the NDMA to determine among six weeks exgratia quantity that may be paid to the relations of these United Nations agency died because of the infection.
- The court's order came in response to a plea seeking ex-gratia of 4 large integer rupees every to the families of all people who succumbed to the virus.
- **NDMA**: **Parent body**: Ministry of Home Affairs.

Primary Objective:







- To coordinate response to natural or synthetic disasters and for capacitybuilding in disaster resiliency and crisis response.
- Origin: NDMA was established through the Disaster Management Act enacted by the govt. of Republic of India in 2005.
- Organisation setup: The Prime Minister is officio chairwoman of the NDMA, United Nations agency chairs a 9member board.
- The remainder of the board consists of members nominated based on their expertise in areas such as, planning, infrastructure management, communications, meteorology etc.
- The day-to-day management of the agency is overseen by the office of the Vice Chair.








Topic 3. Global Cybersecurity Index

Importance for Prelims: International Reports



According to a global organization report discharged, Asian country has jumped thirty seven places to tenth position within the international Cyber Security Index (GCI) 2020.

- About the index: The GCI could be a composite created, analyzed and printed by the International Telecommunication Union (ITU), a specialised agency of the global organization.
- It measures the commitment to cybersecurity of its 194 member countries to lift cybersecurity awareness.
- The latest report is that the fourth GCI edition by the ITU, the primary version of that was launched six years past.







- Each country's development or engagement is assessed on 5 pillars (i) Legal measures, (ii) Technical measures, (iii) structure measures, (iv) capability development, and (v) Cooperation- then aggregate into a composite score.
- Global rankings the highest rank within the GCI was achieved by the U.S. with a score of a hundred.
- The United Kingdom and Saudi Arabia finished second, tied for next place with a score of ninety nine.54.
- In the Asia Pacific region, South Korea and Singapore square measure on high with a score of ninety eight.52, that ranks fourth globally.
- Other countries at the highest of the index embrace Russia, the United Arab Emirates and Asian country (98.06) at fifth place, Republic of Lithuania at sixth, Japan at seventh and North American nation, France and Asian country at the following positions.
- Among different countries. Turkey (97.49)was graded eleventh, Deutschland (97.41) at thirteenth, China (92.53) at thirty third and Israel (90.93) at thirty sixth position.
- Asian country's ranking India graded tenth within the fourth edition of the world Cyber Security Index 2020 (GCI), a big jump of thirty seven places from its previous GCI rank in 2018. Asian country conjointly ranks fourth within the Asia-Pacific region.







Topic 4. BharatNet implementation through Public Private Partnership (PPP) Model

Importance for Prelims: Governance

Recently, the Union cupboard has accorded the approval for revised implementation strategy of BharatNet through Public personal Partnership mode.

- The revised strategy additionally includes creation, upgradation, operation, maintenance and utilization of BharatNet by the concessioner WHO are going to be designated by a competitive international bidding method.

- It aims to supply on demand, reasonable broadband property of two Mbps to twenty Mbps for all households and on demand capability to any or all establishments.

- The Bharat Broadband Network Limited (BBNL) is a special purpose vehicle for management, establishment, and operation of BharatNet.

- Current Account Deficit the present account measures the flow of products, services, and investments into and out of the country.
- It represents a country's foreign transactions and, just like the capital account, could be a part of a country's Balance of Payments (BOP).
- There could be a deficit in accounting if the worth of the products and services foreign exceeds the worth of these exported.
- A nation's current account maintains a record of the country's transactions with other nations that includes net income, including interest and dividends, and transfers, like foreign aid.
- It comprises of following components: Trade of goods, Services, and Net earnings on overseas investments and net transfer of payments over a period of time, such as remittances.
- It is measured as a share of value.
- The formulae for calculative CAD is: accounting = balance + web current transfers + income abroad balance = Exports – Imports a rustic with rising CAD shows that it's become noncompetitive, and investors might not be willing to take a position there.
- In India, the present Account Deficit might be reduced by boosting exports and curb non-essential imports like gold, mobiles, and physics.
- Current Account Deficit and monetary Deficit (also called "budget deficit" could be a scenario once a nation's expenditure exceeds its








along called deficits revenues) unit area and each typically reinforce one another, i.e., a high financial deficit results in higher CAD and contrariwise.

- Anti-bodies will show up between 9-28 days when the infection has set in.
- Antibodies ar proteins that facilitate fight infections & will offer protection once morest obtaining that unwellness again. Antibodies ar disease-specific.
- For example, contagious disease antibodies can defend from obtaining contagious disease if you're exposed thereto once more, however they won't defend you from obtaining epidemic parotitis if you're exposed to epidemic parotitis.







- Serology tests ar crucial for the management & police work of the unwellness. These tests provide insight into the virus's incidence, together with symptomatic or symptomless infections. IgM (Immunoglobulin M) associate degreetibodies develop ahead of time in an infection whereas immunoglobulin G (Immunoglobulin G) antibodies against severe acute respiratory syndrome CoV-2 ar largely found when somebody has recovered from the infection.
- Antibodies could also be detected in our blood for many we tend toeks through when we live COVID-19. though these antibodies may offer some immunity to the COVID-19 virus, there's presently not enough proof to understand however long these antibodies last.

- > Company to price the ZyCoV-D on lines with other Covid-19 vaccines in India



- > Zydus plans to double the production capacity after launch
- > ZyCoV-D is India's first indigenously developed DNA vaccine candidate against Covid-19

Ahmedabad-based **Zydus** Cadila has applied to Central medication normal management Organisation (CDSCO), the national medication regulator, seeking emergency use authorisation (EUA) for ZyCov-D, its Covid-19 immunizing agent.

- ZyCoV-D, designed and developed by Zydus (a pharmaceutical company) with support from the Department of Biotechnology (DBT).

- Sea of Marmara It is a small inland sea that is completely bordered by the transcontinental nation of Turkey.







- It has been named after the Turkish Island of Marmara, whose name was derived from the Greek word Mármaron which means "marble".
- It separates Asian Turkey from European Turkey.
- In the northeast, it is connected to the Black Sea via the Bosphorus Strait, whereas in the southwest, it is linked with the Aegean Sea via the Dardanelles Strait.

Recently, the seventh edition of ocean armed service conference (IONS) was hosted by the French Navy at Réunion Island.

• It may be a biennial event that was planned by the Indian Navy in 2008.

About:

- The IONS may be a voluntary and inclusive initiative that brings along navies of ocean Region littoral states to extend maritime cooperation and enhance regional security.
- It conjointly serves to develop a good response mechanism and humanitarian help and disaster relief (HADR) against natural disasters.
- The chairmanship of IONS has been held by India (2008-10), UAE (2010-12), South Africa (2012-14), Australia (2014-16), Bangladesh (2016-18) and Islamic Republic of Iran (2018-21).
- France assumed the Chairmanship in June 2021 for a two-year tenure.

Members:

- IONS includes twenty four member nations that bit lie inside the ocean Region (IOR), and eight observer nations.
- The members are geographically sorted into the subsequent four

sub regions:

- South Asian Littorals: Asian country, India, Maldives, Pakistan, Seychelles, land and uk (British ocean Territory)
- West Asian Littorals: Iran, Oman, Asian nation and United Arab Emirates
- East African Littorals: France (Reunion), Kenya, Mauritius, Mozambique, South Africa, and African nation.
- South East Asian and Australian Littorals: Australia, Indonesia, Malaysia, Myanmar, Singapore, Siam and Timor-Leste.

How it works?

- If the Centre finds that a definite trade goods is briefly provide and its value is spiking, it will inform stock-holding limits thereon for a nominative amount.
- The States act on this notification to specify limits and take steps to confirm that these area unit adhered to.

Topic 16. India sees consensuses by Oct. on OECD-G20 global tax deal Importance for Prelims: International Relations







Recently, Bharat has declared its connection below OECD/G20 inclusive Frame work aboard Erosion and Profit Shifting (BEPS).

- OECD/G20 Inclusive Framework on Base Erosion and Profit Shifting (BEPS)
- It is a tax deal which consists of two components: Pillar One which is about reallocation of additional share of profit to the market jurisdictions; and Pillar Two consisting of minimum tax and subject to tax rules The framework brings together over 135 countries and jurisdictions to collaborate on the implementation of the BEPS Package.
- The BEPS package provides fifteen Actions that equip governments with the domestic and international instruments required to tackle minimization.
- Significance of OECD/G20 inclusive Framework on BEPS It permits interested countries and jurisdictions to figure with OECD and G20 members on developing standards on BEPS connected problems and review and monitor the implementation of the BEPS Package.








Topic 23. Petrol price rise and issue of tax



- It is charged with the design, promotion, organisation and implementation of programs for the event of textile and alternative village industries within the rural areas.








Topic 28. T cell responses against Variants

- As the names recommend, helper T cells 'help' alternative cells of the system, while cytotoxic T cells kill virally infected cells and tumours.








Topic 29. Electroporation physical Transfection

a team of researchers from IIT-Madras, unitedly with scientists from the united kingdom and Taiwan, have achieved a symbol breakthrough in doing transfection.

- Transfection is that the method of introducing foreign genetic nucleic acids cells. substances like into commonly required for sequence analysis and medical care.
- Single-cell transfection techniques (SCTT) give a stronger understanding between molecules and organelles, which of the interactions might facilitate within the development of medicine and diagnostic tools.
- There square measure 3 ways of doing transfection.
- A) Biological, within which the required genetic material is introduced into an endemic.
- The virus is then used as a truck to require the fabric within the cell. it's a simple methodology, however there square measure undesirable side-







effects because it may trigger AN immuno-response from the body or depart harmful genetic mutations.

- Chemical methodology attaches the cargo (carrier) to the positive ions of bound chemicals (cationic compound, cationic amino acids) and that they get drawn to the charged cell wall.
- This is hard, as a result of it got to match the chemicals to the sort of cell, instead the 'transfection efficiency' are going to be low.
- C) Physical is gaining ground. Here again, there square measure completely different techniques, like microinjection, biolistics and electroporation.
- 1. Micro-injection is simple injection however demands high ability and is grueling.
- 2. 'Biolistics', or biological ballistics, is pricey it desires instrumentation for mix the cargo material with gold and shooting it into the cell employing a gene-gun.
- 3. Electroporation, a additional made-up technique, involves applying an electrical field to the cell, so its permeableness will increase — the holes in its walls get larger, so our cargo passes through.
- For this, it desires extraordinarily little electrodes (at least one thousandth of AN mm) Electroporation,
- The researchers made-up a really precise array of nano-electrodes with the assistance of advanced micro/nanofabrication techniques.
- The gap between 2 nano-electrodes was seventy nanometers and also the interspace between associate degree array of nano-electrodes was five micrometers.
- The electrical pulse creates temporary deliquescent (water-loving) pores, through that the required load might be slipped in. within the experiment, the researchers used their device to deliver into a cell material like cell-







impermeable dyes, quantum dots (nano crystals which will ferry electrons) and plasmids (a quite DNA). Advantages, With Nano-electrodes, the voltage applied is little (4V to 6V) and, owing to this, the cell lives longer (3 to four days).

- The voltage required is massive enough kill cell among minutes once the load gets within the smaller Nanoelectrode the expanse, electrolysis result was virtually negligible, that increased cell viability conjointly, with Nano-electrodes it's potential to settle on wherever to puncture holes within the cell wall.

- This Nano device provides a spatial and temporal indefinite quantity management technique, giving high transfection potency and cell viability.
- This technology may be a vital breakthrough in transfection techniques, which might aid drug analysis.

- The take a look at for denying bail underneath the UAPA is that the court should be happy that a "prima facie" case exists against the suspect.
- The Section 43D(5) reads that no one suspect of associate degree offence punishable underneath Chapters IV and VI of this Act shall, if in custody, be discharged on bail or on his own bond unless the general public prosecuting attorney has been given a chance being detected on the appliance for such unleash.
- It as long as such defendant person shall not be discharged on bail or on his own bond if the Court, on a perusing of the case diary or the report created beneath section 173 of the Code is of the opinion that there square measure affordable grounds for basic cognitive process that the accusation against such person is clear true.
- Law of Bail beneath UAPA each regular bail and bail by default like CrPC square measure on the market beneath UAPA with some alterations beneath section forty three D of UAPA.

- Curious case of Section 43D(5) it's solely applicable to offences punishable beneath chapter IV and VI of the act i.e. offences associated with terrorist acts and terrorist organizations.
- It features a precondition that essentially explains condition once bail shall be denied, i.e. if affordable grounds exist for accusations to be prima-facie true and such call shall be supported rap sheet or case diary.
- The second a part of precondition explains the burden over prosecution and also the prosecution had to prove that affordable grounds exist for accusations believed to be clear true.



- Concern The OPEC+ group ran into sharp criticism from developing economies, for deliberately maintaining low supply levels to raise prices.
- OPEC+ agreed to gradually increase crude production as prices reached \$64.5 per barrel including a phased end to Saudi Arabia's 1 million barrel per day cut in production by July.
- Impact on India If the UAE and other OPEC+ nations do not reach an agreement to increase production in August, expected relief in the form of lower crude oil prices could be delayed.








Topic 35. Glyphosate-based herbicides

- Countries, as well as Luxembourg and North American country, have illegal or restricted the utilization of glyphosate, citing health considerations.








Topic 36. REIT (Real Estate Investment Trust)



- The breaks ar believed to be caused by the northward shifting of the monsoon trough (minimum low cell in ITCZ).
- The axis of the trough lies at the foothills of the Himalayas during the break period.
- During the break period, heavy rainfall occurs over the sub-Himalayan regions and the southern slopes of the Himalayas.
- One or two breaks do occur during the rainy season.








Topic 40. Water disputes and irrigation projects in Krishna and Godavari

Andhra Pradesh and Telangana has been drawing avatar water from four comes, Jurala, Srisailam, NagarjunaSagar, and Pulichintala for hydropower generation

- Telangana wants the Krishna Water Disputes Tribunal-2 to permanently settle the water dispute.








Topic 41. Ramgarh Vishdhari sanctuary








Topic 43. SwabSeq
